



# Privacy Policy and use of Cookies

This policy describes the ways in which we collect , store, use and protect your personal information. By accepting this policy, you agree to such collection, storage and use when you sign up for or use our products, services or any other features, technology or functionality that we offer when accessing our website or by any other means. We may change this policy at any time by posting a new version on our website. The new version will take effect as soon as it is made available on the website. After such notice, you will be deemed to have agreed to any changes made to this policy.

## Unsubscribe Policy (“ Opt -out”)

The user of our services may at any time stop receiving communications from our website. To do so, simply send an email to [info@mcdentaltech.com](mailto:info@mcdentaltech.com) indicating your desire to stop receiving communications, or simply click on the ' unsubscribe ' link at the end of each email.

## information collection

When you visit the MC Dentaltech website , we collect your IP address and standard web access information such as your browser type and the pages you have accessed on our website. If you agree, we will collect the following types of information:

- Contact information – your name, location, age, gender and other similar information.

Before allowing you to use some of the services offered on our website, we may require you to provide additional information that we may use to verify your identity or address or manage risk, such as your date of birth, nationality and other identifying information.

Finally, we may collect additional information from and about you through other means, such as from contacting our customer support team, from the results of your survey responses.

## Cookies Usage Policy

When you access our website, we, including the companies we hire to track how our website is used, will access small data files called “cookies” in your browser . This type of cookie helps us to recognize you if you visit multiple pages on our website during the same session.

We encode our cookies so that only we can access the information stored in them. You are free to refuse our cookies if your browser allows it, but this may interfere with your use of our website.

We and our service providers also use cookies to personalize our services, content and advertising, measure the effectiveness of promotions, and promote trust and confidence. You may encounter third party cookies when using the MC Dentaltech Services on certain websites that are not under our control (for example, if you view a web page created by a third party or use an application developed by a third party, a cookie may be placed by this page or application).

## Protection and Storage of Your Personal Information

Throughout this policy, we use the term “personal information” to describe information that can be associated with a particular person and can be used to identify that person.

We will not consider personal information that must remain anonymous so that it does not identify a particular user.

We store and process your personal information on our computers and protect it under physical, electronic and procedural safeguards. We use computer safeguards such as firewalls and data encryption, enforce file access controls, and authorize access to personal information only to employees who need it to fulfill their job responsibilities.

## Use of the personal information we collect

Our primary purpose in collecting personal information is to provide you with a safe, smooth, efficient and personalized experience. For this, we use your personal information to:

- Provide the requested customer services and support;
- Customize, evaluate and improve our services, in addition to the content and layout of our website;
- Send you targeted marketing materials, service update notices and promotional offers based on your communication preferences;
- Compare information for greater accuracy and verify it with third parties.

## Marketing

We do not sell or rent your personal information to third parties for their marketing purposes without your explicit consent. We may combine your information with information we collect from other companies and use it to improve and personalize our services, content and advertising.

- MC Dentaltech members provide content, products and services (such as registration, transactions and customer support) to help detect and prevent potentially illegal acts and violations of our policies, and to cooperate in decisions regarding your products, services and communications. Members of our corporate family will use this information to send you marketing communications only if you have requested their services.
- Contract service providers who collaborate on parts of our business operations; (fraud prevention, marketing, technology services). Our agreements state that these service providers only use your information in connection with the services they perform for us, and not for their own benefit.
- Companies with which we intend to merge or acquire. (If a merger occurs, we will require the new incorporated entity to follow this privacy policy with respect to your personal information. If your personal information could be used against this policy, you will receive prior notice).
- Law enforcement, government officials or other third parties when:
  - We are required to do so by subpoena, court order or similar legal procedure;
  - We are cooperating with an ongoing police investigation;
  - Other third parties with your consent or guidance to do so.
- Note that these third parties may be in other countries where the legislation on the processing of personal information is different from the Mozambican one. In cases where our company and a partner jointly promote our Services, we may disclose to the partner certain personal information such as the name, address and username of persons who have signed up for our Services as a result of the joint promotion for the sole purpose of enabling us and the partner to evaluate the results of the promotion. In this case, personal information cannot be used by the partner for any other purpose.
- MC Dentaltech will not sell or rent any of your personal information to third parties in the normal course of business and will only share your personal information with third parties as described in this policy.

- If you access our website directly from a third-party website or through a third-party application, any information entered on that website or application (and not directly on our website) will be shared with the owner of that website or application – and your information. may be subject to their privacy policies.
